### A. Ethics Reminder

Chair Melodie Darden called the meeting to order at 9:00 a.m. Chair Darden reminded members of the board of the ethical requirements for public servants and requested that members identify conflicts or potential conflicts of interest with respect to any item on the agenda. No board member expressed any potential or actual conflicts of interest.

#### **II. FOUNDATION CHECK PRESENTATION**

Ms. Beverly Snowden and Mr. Mark Kelly of the Arts Council of Carteret County presented a check for \$4,000 to the Foundation. The donation is to support the College's Black History Committee's ZuZu African Acrobats performance at East Carteret High School on April 12, 2024. Chair Darden said the donation has been matched by the NC Arts Council.

#### **III. SPECIAL RECOGNITION**

Chair Darden recognized Mr. Derek Taylor of Taylor and Taylor, P.A. for his guidance and services as legal counsel to the College for the last 17 years. Mr. Taylor is joining The Town of Morehead City as inhouse legal counsel. Chair Darden expressed deep appreciation on behalf of the College and wished Mr. Taylor well in his new position.

#### IV. APPROVAL OF AGENDA

Chair Darden presented the April 10, 2024, agenda for approval by the Board.

Trustee Penny Hooper motioned to approve the April 10, 2024 agenda. Trustee Wrenn Johnson seconded the motion. The motion passed unanimously by voice vote.

#### **V. APPROVAL OF MINUTES**

Chair Darden presented the March 13, 2024, minutes for approval by the Board.

Trustee Hooper motioned to approve the March 13, 2024 minutes. Trustee Doug Starcke seconded the motion. The motion passed unanimously by voice vote.

#### **VI. CHAIR REPORT**

Chair Darden said she and Trustees Wrenn Johnson, Rosa Langston, Kelly Marek, Will Rogers, and Penny Hooper had attended the NCACCT Law-Legislative Seminar in Raleigh between March 13, 2024, and March 15, 2024. She said trustees had attended multiple sessions and the seminar had been very informative and educational.



Chair Darden said she was very glad the College had sent the Resolution of Support for Propel NC. She said the NCACCT goal was to have at least one letter of support from every county.

Chair Darden said she and Trustees Hooper and Jenkins had attended the opening ceremony for the Public Safety Facility at Laurel Road on April 1, 2024. She said Dr. Mancini and Mr. Perry Harker were also in attendance. She said local firefighters conducted a tour of the facility and demonstrated some dramatic rescue techniques.

Chair Darden said Trustee Hooper had attended the NC Aquaculture Industry and Visioning Workshop on March 21, 2024, and also attended the evening Aquaculture Industry Development Mixer held the same day. She said she heard many wonderful comments about the College Aquaculture program and about Mr. David Cerino, under whose leadership the Aquaculture department is thriving.

Chair Darden thanked Trustee Marek for her Lean and Continuous Improvement presentation to the Executive Leadership Council. She thanked Trustee Jenkins for attending the Solar Eclipse Viewing party on April 8, 2024. She thanked Trustee Henderson and his family for attending the Scholarship Luncheon during which students Tia Harris, Laura Cooper and Taylor Love spoke.

Chair Darden reminded trustees that they were required to complete the Statement of Economic Interest by April 15, 2024. She also asked trustees to mark their calendars for graduation activities in May. She said Awards night is on May 9, 2024, and Graduation is on May 10, 2024.

#### **VII. NEW BUSINESS**

#### Consider proposed alma mater.

Dr. Mancini said she would like to have the Board of Trustees approval for the proposed alma mater song. She invited Mr. Ed Ladenburger to present the alma mater to the board. Mr. Ladenburger shared the lyrics and the musical score.

Trustee Bill Henderson motioned to approve the alma mater presented as the official College alma mater. Trustee Hooper seconded the motion. The motion passed unanimously by voice vote.

## **VIII. COMMITTEE REPORTS**

#### A. Personnel, Policies, and Bylaws

Chair Darden invited Trustee Jenkins to update trustees on Personnel, Policies, and Bylaws committee activity. Trustee Jenkins reminded trustees that the Board of Trustees Self-Assessment survey would be distributed in May. She said survey responses would be anonymous and the results would be discussed in June.

#### B. Ad Hoc

Chair Darden reminded trustees that a revision of the Policies and Bylaws has eliminated the Executive committee. She said the Ad Hoc committee is comprised of the board chair and the current committee chairs. Chair Darden said the Ad Hoc committee met on April 3, 2024, to consider two submittals received in response to the Request for Qualifications for Legal Services, RFQ 84-812030424. She said an



RFQ had been used at the advice of both the North Carolina Community College System Office and Mr. Taylor.

Chair Darden said the Ad Hoc Committee brings to the full Board a motion to appoint Ms. Jane Gordon of Kirkman, Whitford, Brady, Berryman & Gordon, P.A., as the College legal counsel.

Trustee Doug Brady recused himself from the vote on the grounds that his wife, Ms. Carolyn Brady, though now retired, had been a member of the firm.

The motion passed unanimously by voice vote.

#### IX. OTHER REPORTS

#### A. Foundation Liaison

Trustee Hooper said a grant had been awarded from the NC Community College High-Cost Workforce Program Start-up Fund for \$449,840 for the College to start a SurgTech program through Continuing Education. She said several other grant applications were in progress. She said tickets for the ZuZu African Acrobats performance at East Carteret High School on April 12, 2024, were still available and could be purchased online or at the door. Trustee Hooper commented that the Aquaculture department had done a great job on the Aquaculture luncheon and evening social hosted on March 21, 2024.

#### B. President's and Executive Leadership Council Report

Dr. Mancini referenced the reports in the board packet and thanked those who had submitted the reports for the level of detail contained therein. Dr. Mancini called attention to Mrs. Amanda Bryant's report and noted the number of upcoming retirements of long-standing employees, including Mrs. Kay Tosto, Mrs. Donna Cumbie, Mrs. Diane Matlock, Mrs. Trisha Miller, Mrs. Kathy Foster, Mrs. Debbie Favorite and Mr. Luther Curtis. Mrs. Bryant commented that there were another nine pending retirements.

Dr. Mancini said her report included details of Mr. Linwood Parker's recent visit and tour of the College. Mr. Parker founded Parker Boats, now Parker Offshore. She said Mr. Parker had been very impressed with updates to the boat building program. Dr. Mancini said she was thrilled that Parker Offshore will be honored at the NC Community Colleges' Pinnacle Awards being held on April 17, 2024. Parker Offshore will receive the Pinnacle Award for Business (< 500 employees) of the Year. The award recognizes businesses demonstrating a partnership with the NC Community College System (NCCCS) through workforce development programs. Dr. Mancini said she, Chair Darden, and VP Perry Harker would attend the Pinnacle Awards and she is looking forward to the release of a promotional video that will feature Parker Offshore and the College.

Dr. Mancini said she was very proud to announce Dr. Maggie Brown had been appointed to serve on a committee with the NC Community College System Office to look at the process for start-up, amendment and termination of curriculum programs. Trustee Bill Henderson asked how many would serve on the committee. Dr. Mancini said the committee would be made up of four chief academic officers and four presidents.

Dr. Mancini said she and VP Perry Harker had attended the adult learner convening hosted by the John M. Belk Endowment in Greensboro on April 3 and April 4, 2024. She said the convening addressed how



to best service adult learners, for example the scheduling and length of classes, and also the background or support services that are needed for adult learners.

Dr. Mancini said she was delighted to announce Ms. Kristian Jenkins was honored by the North Carolina Comprehensive Community College Student Government Association (NC4 SGA) Conference, as the NC4SGA Advisor of the Year for the Eastern Division of North Carolina.

Dr. Mancini said trustees were aware Tony Pile, a Carteret CC student, is the current statewide N4C SGA president. Dr. Mancini said she was thrilled to now recognize Jennifer Maldonado-Castro, who will not only be taking over from John Martin as the 2024-2025 Carteret CC SGA president, but has also been elected to be the statewide president. Dr. Mancini said it is a tremendous achievement for the College to have produced the statewide SGA president for two consecutive terms.

Dr. Mancini said she was pleased to report that letters of support for Propel NC had been submitted by Carteret Health Care and Parker Offshore.

#### C. Student Government Association Report

Mr. John Martin reported that, at the last SGA meeting, members had been informed of proposed changes to the student and advisor travel policy. He said he had been happy to have Dr. Mancini in attendance at that meeting and available for questions. Mr. Martin said students had enjoyed the Solar Eclipse Viewing party and added that the SGA had donated desserts for the party. Mr. Martin said SGA elections are underway. He confirmed that Jennifer Maldonado-Castro will serve as the SGA president for the 2024-2025 school year and that he will be the vice president. Mr. Martin said Spring Fling, including Take Back the Night, is scheduled for April 10, after the board meeting. Mr. Martin said a QR code for a survey was available to the SGA's Senate meeting. The survey allows students to make recommendations on what the SGA might do better. The QR code will also be sent out via email.

Chair Darden invited Board comments.

#### **BOARD COMMENTS**

Trustee Bill Henderson said he was excited to learn that Dr. Joe Barwick would be the graduation speaker.

Trustee Jenkins thanked Mr. Ladenburger for his work on the alma mater.

Trustee Langston said she was excited about the ZuZu African Acrobats. She encouraged trustees to continue to participate in grant and fundraising efforts. Trustee Langston said she attends a lot of education meetings at the local and state level and noted Carteret CC gets a lot of positive recognition.

Trustee Doug Starcke said he is always happy to have the meeting start with Ms. Reash and a Foundation check presentation and he was excited about the alma mater.

Trustee Catherine Parker said she appreciates that the College is being represented very well at the state level and in our community and she wanted to thank everyone for their efforts.

Mr. John Martin expressed his thanks to the College for enabling students to attend conferences. He also said he had been able to attend a finance committee and had found it very eye-opening to see how much it actually costs for students to participate in those conferences.



Trustee Marek congratulated the SGA for the work they are doing locally and at the state level. She said she liked what she had heard about adult learners and the efforts being made to make workable schedules for those adult learners.

Trustee Penny Hooper said she agreed with everything that had been previously said and recognized that the ZuZu African Acrobats had received support from both the local and the state arts council, demonstrating the collaboration needed to bring these events to the community. Trustee Hooper also commented that the College gets praise at the state level and thanked Dr. Mancini for her efforts. Dr. Mancini commented she has a good team.

Trustee Johnson said she agreed with Trustee Langston that it is great to hear recognition of Carteret CC at the state level. She commented that Dr. Mancini always defers praise to her team but noted that Dr. Mancini is responsible for picking her team.

Trustee Rogers said that he had enjoyed the NCACCT Law-Legislative Seminar. He said that there had been a lot to learn and that he would like to attend more seminars. He said he had appreciated learning more about Propel NC and it had been especially useful to learn more about the complicated financial formulas applied to determine funding.

Chair Darden said she wanted to continue the theme of how well everyone was doing their jobs. She commended Ms. McMahon on the prior meeting minutes and said Ms. Cumbie's budget preparation was outstanding, with the budget-to-actual graph showing minimal variance. She said Mr. Nathan Branson and his team had done a very thorough and good job on the FEC survey, and with their analysis of the survey. She complimented them on doing so, especially because this was in addition to their regular jobs. Chair Darden also congratulated Dr. Brown on her nomination to the NC Community College System Office committee.

#### **XII. CLOSED SESSION**

Chair Darden requested a motion to go into Closed Session at 9:47 a.m. in accordance with N.C. GS 143-318.11(a)(6). Trustee Langston motioned to go in to Closed Session. Trustee Starcke seconded the motion. The motion passed unanimously by voice vote.

Trustees asked Ms. Angela McMahon to stay.

A motion was made to come out of Closed Session at 11:23 a.m. by Trustee Bill Henderson and seconded by Trustee Doug Starcke. The motion passed unanimously by voice vote.

Chair Darden said the motion on the floor is that Dr. Mancini's annual county supplement be increased to \$42,000, effective July 1, 2024, and that she will receive a \$4,000 performance bonus to be paid in the July 2024 paycheck. Trustee Jenkins moved the motion. Trustee Bill Henderson seconded the motion. The motion passed unanimously by voice vote.

#### XIII. ADJOURNMENT



There being no further business, Trustee Langston motioned to adjourn at 11:26 a.m. Trustee Jenkins seconded the motion. The motion passed unanimously by voice vote.

#### **Policy Statement:**

Carteret Community College in compliance with and as required by Title IX of the Education Amendments Act of 1972 and its implementing regulations ("Title IX") and other civil rights laws, as well as in furtherance of its own values as a higher education institution, does not discriminate on the basis of race, color, national origin, sex, sexual orientation, gender, gender identity, gender expression, pregnancy, disability, age, religion, veteran status, or any other characteristic or status protected by applicable local, state, or federal law in admission, treatment, or access to, or employment in, its programs and activities.

Discrimination and harassment oppose the values and standards of the College and are incompatible with the safe, healthy environment that our College community expects and deserves and will not be tolerated. The College is committed to providing programs, activities, and an education and work environment free from discrimination and harassment.

As required by Title IX this Policy prohibits discrimination and harassment on the basis of sex (sex-based harassment). This policy also prohibits retaliation against any individual that complains about violations under this policy or against individuals who participate in investigations of alleged misconduct as outlined in this policy or related procedures.

The President shall ensure the development and maintenance of procedures that are consistent with the afore mentioned values and that comply with Title IX and other applicable regulations. The established procedures which are published in the College Catalog & Student Handbook, will encourage and support the prompt reporting of, and timely and fair resolution of complaints of sex discrimination and harassment.



#### **Definition of Terms:**

Sex-based harassment" is a form of sex discrimination and means sexual harassment and other harassment on the basis of sex, including any of the following:

- Quid pro quo harassment where an employee, agent, or other person authorized by the College to provide aid, benefit, or service under the College's educational programs or activities conditions the provision of an aid, benefit, or service on an individual's participation in unwelcome sexual conduct, whether done so explicitly or impliedly; or
- 2. Hostile environment harassment which is unwelcome sex-based conduct that, based on the totality of the circumstances, is subjectively and objectively offensive and is so severe or pervasive that it limits or denies a person's ability to participate in or benefit from the College's education program or activity; or
- 3. "Sexual assault," as defined in 20 U.S.C. § 1092(f)(6)(A)(v): an offense classified as a forcible or nonforcible sex offense under the uniform crime reporting system of the Federal Bureau of Investigation; including dating violence, domestic violence and stalking.

"Retaliation" means (1) any adverse action including direct and indirect intimidation, threats, coercion, discrimination, or harassment, including charges for conduct violations that do not involve sex discrimination or harassment or sexual harassment but that arise out of the same facts or circumstances as a report or complaint of sex discrimination or harassment or a report or formal complaint of sexual harassment) that is (2) threatened or taken against a person (a) for the purpose of interfering with any right or privilege secured by Title IX; or (b) because the person has made a report or formal complaint, testified, assisted, or participated or refused to participate in any manner in an investigation, proceeding, or hearing related to Title IX.

He was invited to speak to Wake STEM Early College students regarding Workforce Development, Clean Energy Jobs, and Carteret CC's plans to support Global Wind Organization (GWO) training and certification with the Governor and representatives from TotalEnergies and Duke Energy, partners in the Carolina Long Bay project near Wilmington.

More than 30 retirees attended our third annual **Retiree Luncheon** on Tuesday, April 30, in the Hospitality and Culinary Arts Center, including second president of Carteret CC **Dr. Donald W. Bryant**. **Gary Plough** won the longest-ago serving award for having started working at Carteret CC in 1968. Our Culinary and Baking & Pastry Arts students outdid themselves, serving an amazing meal.

On May 10, 188 students will walk in the College's 60<sup>th</sup> Commencement Exercises in the Crystal Coast Civic Center. The estimated number of students who will complete a curriculum degree, diploma, or certificate this spring/summer is 305, with an estimated 257 unduplicated completers. Forty-five students from Career and College Ready program areas (ESL, Adult High School) will walk in that group's graduation on May 8, to include 12 in Adult High School and 21 in High School Equivalency. In addition,



our Continuing Education programs report that more than 729 students have completed certifications and training programs in 2023-2024. We celebrate all of our students and their accomplishments and wish them the very best as they move on to their next challenges and endeavors.

We wrap up our **60**<sup>th</sup> **Anniversary Year of Celebration** this month, with a College Convocation in the updated **Joslyn Hall** on May 13 and a rededication/thank you event for our "Every Seat Matters" Campaign for **Joslyn Hall** on May 16. The Basic Skills Graduation Ceremony is Wednesday, May 8, 2024, at the Crystal Coast Civic Center; the event will begin at 4 p.m. We will honor students who have completed the Adult High School Diploma and the High School Equivalency (formerly GED) diploma. Dr. Maggie Brown will be our commencement speaker. Please join us for this special event.

Last month, the Certified Nursing Assistant program had its first student compete in SkillsUSA. The student, Jeffery Floyd, competed and finished first in his competition category. Congratulations to Jeffery Floyd.

We have scheduled the Firearms Training System (FATS) on campus in May for local law enforcement firearms certification. The FATS training is a computerized simulated system that uses shoot/don't shoot scenarios requiring officers to respond in various real-life situations.

We completed ServSafe certification training for Jim Dandy and Bayside Restaurant employees. ServSafe is a required sanitation and safety certification for employees in the hospitality industry.

We conducted an on-site Captain's License and Assistance Towing course for active-duty United States Coast Guard personnel at USCG Base Fort Macon.

Beaufort Ole Town Rotary awarded a \$2,000 grant for fire training equipment and Crystal Coast Fire Academy instructor uniforms. The equipment will be utilized at the Public Safety Training Facility.

Liz Hubbard, our Re-entry coordinator, attended last month's 2024 Rehabilitation and Re-entry conference in Raleigh, NC.


